- 4. The author(s) must certify that the accepted paper is not copyrighted and has not been published elsewhere.
- 5. Papers will be arranged for presentation and publication ONLY if at least one of the authors registers for the Conference by the registration deadline, <u>31 August 2013</u>.
- 6. An individual author may not appear on more than <u>two</u> papers.
