Dean's Message

Professor Bradley R. BARNES, Dean of the School of Business

Dear Friends,

It is with great pleasure and a huge privilege to commence my third term as the Dean of the School of Business at HSU. Over the last five years we have seen the School which had evolved from having just a handful of programmes to now hosting ten exciting BBAs and two excellent post-graduate programmes. We have continued to work relentlessly during these very challenging times that the pandemic has caused. The declining demographics surrounding Hong Kong school leavers, coupled with the exodus of many local families have made life difficult for us. We have had to dig deeper and work harder than ever to simply stand still. However, I firmly feel that we have weathered the storm well and there is light at the end of the tunnel.

I saw the light this summer, as I went to the U.K. on conference and stayed in Yorkshire, 'God's own country'. My mother sadly passed away during the pandemic and it was the first time that I was able to see my father since, as well my two children. Having spent a few days in the U.K., I then took my son and daughter on a tour of South East Asia. We spent a few days in Singapore, before going to Johor Bahru, Malacca, Kuala Lumpur, Penang and Bangkok. Visiting all these places provided me with renewed confidence, and the light. I discovered that for all these locations, it was 'business as usual'. Mask wearing was voluntary rather than mandatory and it was great to see happy people smiling and going out. I think the pandemic hit many of the places quite badly, particularly I saw Kuala Lumpur, as I had never experienced it before, with so many closures of bars, cafes and restaurants. No longer was it so vibrant like in the past. However, travelling around gave me the confidence to realise that it's only a matter of time until Hong Kong follows in the direction of Singapore, and hopefully the Mainland will also

open up.

On return to the office, I was delighted to receive confirmation that I had been granted continuous service, to remain at HSU as a Professor. I have been quite lucky since taking post here, having some 20 publication acceptances. Much of the research work was undertaken during the weekends, as being the Dean of the School of Business is often demanding. However, I am very grateful to all my colleagues and coauthors for their patience and support during my Deanship. In addition, the research has not gone unnoticed. I am pleased to share with you that based on my publications and their citation impact, Research.com included me in the top 50 of Business & Management Scientific scholars in China. It's a nice achievement for us at HSU, as I represent our university and position us among many leading universities and elite scholars in Hong Kong and China.

Finally, I would like to take this opportunity to say special thanks to all my friends and colleagues both within the School and across the University. I have really enjoyed working with you all. I love the environment that we have created and really think we have something very special here.

Business School Gala 2022

The School of Business was proud to host the Business School Gala during 27—30 June 2022 (Monday to Thursday), which was an open week for the public and SBUS alumni. During the week, the School not only announced the IIth HSUHK Junzi Corporation Award and Hong Kong Business Ethics Index, but also collaborated with Departments to conduct a series of alumni events to connect our faculty members and current students with alumni.

Announcing the 11th HSUHK Junzi Corporation Award and Hong Kong Business Ethics Index

The Hang Seng University of Hong Kong (HSUHK) introduced the concept of "Junzi" character in Confucianism in 2011 whereby an annual Junzi Corporation Survey (the Survey) is conducted to measure the overall level of business ethics in Hong Kong. The Junzi Corporation Award is conferred to felicitate Junzi corporations that meet high ethical standards with the five Junzi virtues of "Ren (benevolence)", "Yi (righteousness)", "Li (propriety)", "Zhi (wisdom)", "Xin (trustworthiness)".

This year's Junzi Corporation Award Ceremony was hosted on 28 June 2022. Professor Simon HO, President of HSUHK, delivered a welcome speech followed by Dr. Thomas MAN, Associate Dean (Enterprise and Business Engagement) who announced the Junzi Index. Professor Robin SNELL presented a theoretical framework on the five Junzi virtues and its implementation in business contexts. After President HO and Professor YV HUI (Provost and Vice-President (Academic and Research)) respectively presented







the Junzi Corporation Exemplary Award and Corporation Award, Mr. Calvin CHAU, President of The Hong Kong General Chamber of Small and Medium Business, gave a speech and conferred the Corporation Awards (Small and Medium Enterprises) to the Awardees.

To create and promote new knowledge as its teaching goals, HSUHK is committed to cultivating global leaders with discerning thinking, innovation, humanistic care, moral values and social responsibility. At the same time, HSUHK has been upholding its spirit of actively promoting business ethics and fostering a conducive and sustainable business environment. Since 2011, faculty members and students of HSUHK have made tremendous efforts to compile the Business Ethics Index by undertaking rigorous academic research that reflects the five Junzi Virtues.

The HSUHK Business Ethics Index reflects the public's comprehensive evaluation of the ethical level of the business community. The results of this year's survey show that the Index recorded an increase to 63.7 (out of 100) after a sharp rebound in 2021. It reflects that the overall level of business ethics in Hong Kong perceived by Hong Kong citizens has increased during the pandemic.

In addition to the Award Presentation, the School took this opportunity to host a Business Leaders Forum on "How Should Hong Kong Businesses Thrive amid Pandemics?" The Forum was

President HO pointed out that "the concept of the five Junzi virtues is, in fact, more comprehensive and beyond the Western business ethics. Not only enterprises should avoid wrongdoings, they need to promote good deeds." HSUHK hopes that the Junzi Corporation Award will encourage more enterprises to adopt a Junzi demeanour. At the same time, the survey provides a useful yardstick with great reference value for the public.





In addition to the Award Presentation, the School took this opportunity to host a Business Leaders Forum on "How Should Hong Kong Businesses Thrive amid Pandemics?" The Forum was hosted by Professor Jeanne FU, Head of the Department of Management, with the guest Mr. CHENG Chi Wai Ellis, Chief Financial Officer, Kerry Logistics Network Limited who shared with us practical examples on data security and staff welfare that reaped long term reward. He also emphasised that enterprises must continuously innovate amid and post pandemic to suit the dynamic business environment globally.

The top scholars selected are ranked with reference to the H-index, a measurement of the productivity and citation impact of scholars' publications, and other bibliometric indicators.


Professional Bodies Briefing Session – Series 1

The Department of Accountancy organised the first Professional Bodies Briefing Session for the Academic Year 2021/22 to provide students with the latest information on various professional bodies and their respective qualifications.

Representatives of the Association of Chartered Certified Accountants (ACCA), CPA Australia and the Hong Kong Institute of Certified Public Accountants (HKICPA) (arranged in an alphabetical order) were invited to introduce the main features of their professional qualifications and examinations.

An in-house sharing session, facilitated by our ACY teachers, was subsequently held to render advice to students on pursuing the right professional qualifications. Our ACY teachers also reminded students to keep track on their study progress to ensure they meet graduation requirements for sitting professional examinations.

Partnership with Tricor Hong Kong for an Exclusive Traineeship Programme for HSUHK students



The Department of Accountancy was glad to collaborate with Tricor Hong Kong and announced the Exclusive Traineeship Programme at an online orientation on 31 May 2022.

The Hang Seng University of Hong Kong (HSUHK), for the first time, partnered with Tricor Hong Kong to launch a traineeship programme for its students. Students at the university who are in their third- or fourth-year majoring in Accounting, Corporate Governance and Compliance, Management and Human Resources Management are welcome to apply. Under the programme, participating students enjoy a one-year (for third-year students) or 6-month traineeship (for fourth-year students). During the programme, they have an opportunity

to gain real life work experience by working as a trainee at Tricor two days a week throughout the school year and full time in the summer holiday.

Apart from the opportunity to work closely with Tricor professionals across different divisions, the programme comprises learning and exposure, networking, as well as monitoring and evaluation.

President HO is impressed with the well-designed internship programme. It not only equips students with practical work experience, but also provides training on professional industry knowledge, soft skills and business presentation, as well as precious opportunities to network with field practitioners.

Guest Lecture on Recent Financial Policy Development in Hong Kong: Environmental, Social and Governance (ESG) and Beyond cum Personal Tutor-tutee Networking #1

The first Guest Lecture cum Personal Tutortutee Networking for this academic year was successfully held on the theme of "Recent Financial Policy Development in Hong Kong: Environmental, Social and Governance (ESG) and Beyond".

With the growing concerns about ESG in the business world, Dr. Rocky TUNG, Director and Head (Policy Research) at Financial Services Development Council, was invited to discuss with students how this concept surged significantly

over recent years and how Hong Kong could seize the opportunity with the use of sustainable investment strategies.

Besides, to let students familiarise themselves with other schoolmates and teachers, the Personal Tutor-tutee networking session was held before the Guest Lecture. Students reflected on their learning experience and received useful advice from personal tutors for formulating plans for academic and professional development.







ACY Online Seminar in March 2022 Corruption Prevention and Application of Financial Statements

The ACY Online Seminar in March was successfully held on 24 March 2022, dually themed in "Corruption Prevention" and "Application of Financial Statements".

Speakers shared the common factors leading to financial difficulties and the lessons learned from the cases seeking professional counseling. From the sharing and discussion, all of the participants took away useful tips and kits for formulating smart personal finance strategies by using electronic payment and action plans.

While electronic payment services in Hong Kong are boosted in every way, there are merits of using e-payment methods. Meanwhile, however, there are financial traps if they are not mastered well, especially for youngsters. They should know more about the pros and cons of e-payment methods before they get more freedom in using money and making spending decisions when moving to high school and tertiary institutions.



EAF Career Series Workshops

The EAF Career Series Workshops were conducted online in collaboration with SAO (Career Planning & Development) for students who were looking for employment in the field of banking and finance. The objective was to help students acquire the essential skills necessary for job hunting. It focused on HSUHK Graduate Employment Statistics, Job Market Information and Searching Skills, Resume and Covering Letter Writing Skills, Interview Skills and Demonstration of Aptitude Tests.

Afterwards, the second career series workshop was held. Dr. Charles LAM, MD Barings Private Equity Real Estate; Dr. Eva CHAN, Chairman of Hong Kong Investor Relations Association and IR Head of CC Land (Stock code: 1224) and Dr. Michael WU, Chairman of Creative Asset Management Limited and former Chief Executive Officer of China Chengtong Asset Management (Hong Kong), which is part of the China Chengtong Holdings Group Ltd,

and help to oversee the H-share of the RMB 70-billion equity of listed CSOE firms attended the workshop. They shared the reasons of integrating accounting data analysis in financial market operations being an important skillset for students' careers in accounting and finance. year 3) won the Certificate of Excellence, while a team with four year 1 students received the Certificate of Merit.










Contest of "Promotion of Corporate Governance among Young People"
