We also provide opportunities for internships and outbound student exchange programmes, enhancing the learning experience and preparing students for successful careers after graduation. Our graduates have secured positions in prestigious professional service firms, listed companies, and government or regulatory agencies. Additionally, many alumni have pursued postgraduate studies, both in Hong Kong and overseas. The Programme is further supported by a generous grant from Dr Rose W. M. Lee, which includes scholarships available for new entrants in Year 1 and Year 3.

PROGRAMME OBJECTIVES

課程目標

The Programme aims at providing students with necessary knowledge so that graduates are prepared for career development as corporate governance and compliance professionals. Upon completion of the BBA-CGC, graduates will be able to develop a good understanding of the laws and regulations in corporate governance and assist the board of directors in implementing an effective compliance system. Our goal is to nurture graduates with entrepreneurial spirit and a strong foundation in laws, regulations and practice of compliance.

香港恒生大學於 2014 年開設了工商管理企業管治與合規（榮譽）學士課程，課程多樣化的設計旨在使學生掌握理論知識和實踐應用，涵蓋企業管治、監管架構、風險管理和合規等多個領域。我們的教師團隊由行業專家和學者組成，為學生提供有關企業管治和合規的最佳實踐見解。

我們還為學生提供實習和海外交流的機會，這將增強他們的學習體驗，並為畢業後的成功職業生涯做好準備。我們的畢業生往往被知名的專業服務公司、上市公司以及政府或監管機構聘用。我們的部分校友也在香港或海外大學繼續攻讀研究生課程。此外，本課程榮獲李慧敏博士的慷慨支持，包括為一年級及三年級新生設立的入學獎學金。

CAREER OPPORTUNITIES AND DEMAND FOR CORPORATE GOVERNANCE PROFESSIONALS

市場需求及就業前景

Recently there has been a global effort to strengthen corporate governance and compliance with the goal of combatting fraudulent activities and detecting financial crimes including money laundering. As a result, there is an increasing demand for qualified personnel who have a good understanding in laws and regulations and who are able to assist the board of directors in implementing an effective governance system. We have a newly-launched internship programme with a leading Hong Kong business service firm to employ our students during their studies and after graduation.

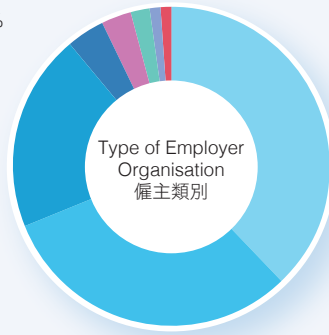
The BBA-CGC provides a solid foundation for graduates who wish to continue their academic studies at the Master's level. Some of our graduates have gone on to pursue MBA (Master of Business Administration), MAcc (Master of Accountancy), and MCG (Master of Corporate Governance) degrees from leading universities in Hong Kong, Australia, and the United Kingdom. In addition, graduates who have completed accredited MCG programmes may get exemptions from professional qualification examinations, subject to the fulfilment of requirements.

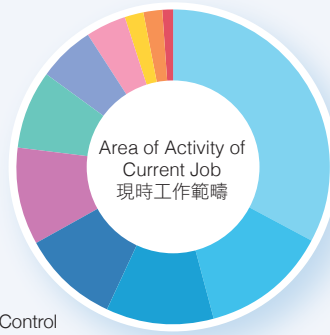

COLLABORATION WITH PROFESSIONAL BODIES

HKCGI has accredited the Partnership Bachelor's Programme (PBP) of our Programme. Graduates of the PBP are eligible for exemptions from up to four modules in the Chartered Governance Qualifying Programme (CGQP). Furthermore, the HKCGI Student Ambassadors Programme (SAP) provides a platform for students to cultivate their potential as future leaders in governance and compliance. Through mentorship opportunities, internships, networking activities, and professional workshops offered by the SAP, student ambassadors receive valuable support for their personal growth and career development.

OVERSEAS EXCHANGE PROGRAMME

HSUHK has engaged in exchange partnerships with a number of renowned overseas institutions. These institutions exchange students with HSUHK each year. Students are encouraged to participate in the exchange programme to broaden their horizons and to gain valuable experience.

HSUHK JOCKEY CLUB RESIDENTIAL COLLEGES

HSUHK is the first self-financing institution to adopt elements of a Residential College approach. The new Residential Colleges with 1,200 places are established so that students could benefit from the dynamic and inspiring hall life education programmes. The themes of the four Residential Colleges are Cultural Diversity, Healthy Living, Community Service and Sustainability, which echo the University's "Liberal + Professional" education model.

SCHOLARSHIPS

HSUHK offers a wide range of scholarships/awards to its students for rewarding and recognising high calibre students with outstanding performances in both academic and non-academic aspects, as well as supporting students to broaden their exposure to multicultural environment. With the generous support from the government and donors, there are increasing scholarship opportunities at HSUHK. In 2024/25, HSUHK is privileged to disburse over HK\$18 million in scholarships and financial assistance to students. Specifically, our students have received the following scholarships in the past:

FREQUENTLY ASKED QUESTIONS 常見問題

Q : Why would I choose the BBA-CGC in HSUHK, and how is it different from other programmes?

A : Our Programme not only equips students with a high level of literacy in accounting, taxation, corporate secretaryship and administration, but also emphasises training relating to risk management and compliance.

問：我為何要選擇恒生大學的企業管治與合規工商管理課程？與其他學位課程相比，它有何特色？

答：我們的課程除提供卓越的會計、稅務、公司秘書及行政課程，還注重風險管理及合規實務的培訓。

Q : Are there any admission interviews?

A : Applicants may be invited for an admission interview which provides an opportunity for applicants to gain a deeper understanding of the profession and the Programme.

問：招生程序是否包括入學面試？

答：視乎申請人數，學生或會獲邀出席面試，面試或有助申請人加深了解此專業和課程。

Q : Is this Programme open for application into senior year's study (e.g. Year 3)?

A : Our Programme welcomes applications for Year 2 and Year 3 entry. Credit transfer may be granted for modules successfully completed at other accredited tertiary institutions.

問：高年級學生能否申請此課程？

答：本課程歡迎二年級及三年級入學申請，申請人在其他認可專上院校取得的學分經審核後可獲轉換至恒生大學。

Q : What are the career options for graduates?

A : There is a rising demand for corporate governance and compliance professionals in recent years. Graduates would have a wide range of career options, such as company secretaries, corporate administrators, compliance officers, accountants and management trainees, etc. According to the data from a global economic research consultancy, the average annual salary for a company secretary is around HK\$1.1 million. Other recruitment websites show that the average annual salary for a company secretarial assistant is around HK\$300K to HK\$420K.

問：完成此課程後，畢業生有何出路？

答：近年工商界對企業管治與合規方面的人才需求殷切，畢業生將有廣泛的就業選擇，例如成為公司秘書、公司管理人員、合規專員、會計從業員、管理見習生等。根據一間環球經濟研究顧問公司的數據顯示，公司秘書的平均年薪大約為 110 萬港元。其他招聘網站顯示公司秘書助理的平均年薪約為 30 萬至 42 萬港元。
